#### 4. RESERVATION OF POSTS:

Reservation for SC/ST, OBC [Non-creamy layer], PWD, EWS (Economically Weaker Section) and Ex-Servicemen categories will be applicable as per the Govt., guidelines from time to time. PWD candidates will be drawn from any of the trades.

The persons belonging to EWS, who are not covered under the scheme of reservation for SCs, STs and OBCs shall get 10% reservation, which may be drawn from any of the Trades in Tradesman- C posts.

## 5. AGE:

35 years is the upper age limit for unreserved candidates as on 31.05.2019.

## 6. RELAXATIONS:

Age is relaxed by 5 years for SC / ST, 3 years for OBC [Non Creamy Layer] and 10 years for Persons with Disabilities [degree of disability 40% or above]. Ex-servicemen are eligible for age relaxation for the service rendered in Defence plus three years.

Special relaxation as applicable for the Tradesman-C post, is as follows :

35 years is the upper age limit for unreserved candidates as on 31.05.2019. However, the maximum age relaxation is allowed up to 40 years for those who worked/ working with ECIL as Sr. Artisan/Jr. Artisan on fixed tenure based contract with ITI qualification or with ITI+NAC.

The resultant applicable relaxation for SC/ST/OBC/PWD candidates will also be allowed on the above mentioned special relaxation. Such candidates will have to compete with other eligible candidates in written test/trade test etc.

Experienced candidates are required to produce certificates giving the details such as duration, the field of experience and nature of products manufactured/services rendered by the organization. Contract workmen engaged by the Company as Sr. Artisan/ Jr. Artisan on Fixed Tenure Based Contract are required to specify the Employee Code No. allotted by ECIL to them, duration of Engagement, Name of the Group/Division and also produce the Service Certificate issued by ECIL. The decision of ECIL regarding authenticity/genuineness of experience certificates and relevance of experience will be final and binding. Except those who worked/working with ECIL as Sr. Artisan/Jr. Artisan on fixed tenure based contract with ITI qualification, no other candidates worked/ working with ECIL will be extended the special relaxation of upper age.

**Note:** The upper age limit with all relaxations shall not exceed 55 years. The below table mentions the respective Upper Age Limit for candidates across categories:

## 7. EXEMPTIONS:

**Fee exemption:** Candidates belong to SC/ST/PWD, Ex-servicemen and Sr. Artisan/ Jr. Artisan on fixed tenure based contract working with ECIL are exempted from payment of Application Fee. Internal [Regular] employees are exempted from payment of Application Fee.

## 8. MODE OF SELECTION:

- The selection will be made strictly on the basis of merit.
- The candidates have to qualify in Written Test and Trade Test by securing at least 50% marks in each test and a total of minimum 60% in aggregate. There shall be no interview.
- Final merit list will be prepared considering the score of both Written Test & Trade Test.**
- The Question Paper will be in English only. The Written Test shall be of Multiple Choice Questions (MCQ) Type. Each question carries one mark and there will be no negative marks.
- The duration of the test will be 90 minutes.**
- The Answer Sheet will be OMR Sheet.
- Syllabus for Written Test will be restricted to subjects studied in ITI and NAC.

## **I. WRITTEN TEST**

The date, time and venue of written test will be intimated by e-mail / SMS. The candidates have to download the Hall Ticket for **Written Test** from the link provided on our website: <http://careers.ecil.co.in>. The candidates have to bring their **Hall Ticket along with ID-Proof** [viz. Aadhar, PAN, Voter-ID, Driving License or any of the ID proofs issued by Govt.] for attending written test along with **Application Fee receipt if applicable**. The candidates have to use only **black ball point pen** for OMR sheet. The candidates, who are shortlisted through written test, will only be called for Trade Test, subject to production of all documents at the time of document verification.

## **II. DOCUMENT VERIFICATION PROCESS:**

The short-listed candidates for **Trade Test** will be called for the process of Document Verification one day before the Trade Test. Only after satisfactory verification of documents the candidates will be permitted to undergo Trade Test. At the time of verification, the following certificates should be produced in original as appropriate:

1. On-line registered application form duly signed and with recent colour passport size photo, Hall Ticket;
2. Matriculation/10<sup>th</sup> Standard or equivalent certificate as proof of Date of Birth, identity proof issued by Govt., like Aadhar, PAN, Driving License, Passport etc., qualification, experience, latest caste & disability (PWD) certificates, Discharge Certificate (for Defence Personnel) if any along with a set of photo copies, thereof.
3. NAC issued by NCVT in the relevant trade .
4. No Objection Certificate from their establishment in case of Govt., Servants of Central / State / PSUs etc.
5. All original certificates in support of his / her qualification, experience, latest Certificate of caste [SC/ST/OBC]/ EWS/ PWD etc., if applicable, along with a set of photo copies, thereof.
6. OBC candidates seeking reservations should submit certificate (not older than 06 months) issued by the Competent Authority in the prescribed format as available in ECIL Career Website.
7. Fee Receipt as applicable;
8. If claiming age relaxation as candidate from J&K, relevant certificate;

Inability of the candidates to produce the requisite documents at the time of document verification shall render them liable for non-consideration of their candidature. No undertaking for production of documents in respect of eligibility criteria with regard to age, qualification & experience on a later date will be allowed.

## **III. TRADE TEST:**

The date, time and venue of **Trade Test** will be intimated by e-mail / SMS. The candidates have to download the **Hall Ticket for Trade Test** from the link provided on our website: <http://careers.ecil.co.in>. After necessary verification process, the eligible candidates will be called for Trade Test and such candidates shall bring their Hall Ticket along with any one of the ID Proofs i.e. Aadhar, PAN, Voter-ID, Passport, Driving License or any of the ID proofs issued by Govt.

## **9. GENERAL CONDITIONS:**

- a) The candidates who worked in ECIL as Sr. Artisan / Jr. Artisan on fixed tenure based contract should enclose their service certificate and relieving certificate issued by ECIL. Further, the candidates working in ECIL as Sr. Artisan / Jr. Artisan on fixed tenure based contract should route their application through proper channel as indicated in the Personnel Circular.
- b) Post Qualification Experience/ Age etc., will only be counted as on **31.05.2019**.
- c) Before applying, candidate should read the complete advertisement carefully and ensure that he / she fulfill eligibility criteria of post notified in the advertisement in all respects.
- d) A non-refundable Application Fee of **Rs. 500/-** is applicable for General & OBC candidates.

- l) **The short-listed out-stationed SC, ST & PWD candidates for Trade Test will be paid II class Travelling Expenses (to & fro rail fare) by the shortest route to the Place of Trade Test [i.e., from nearest railway station as per address for correspondence (within India) mentioned in the Application form, subject to production of documentary proof, as per ECIL rules through online Bank Transfer only, on submission of requisite particulars of Bank Account.**
- m) The short-listed candidates for Trade Test have to produce original certificates in support of educational qualifications, age, experience, caste, PWD (wherever applicable) etc. if any, at the time of document verification without which candidates will not be permitted to take the Trade Test.
- n) The application is liable for rejection at any stage of recruitment process in case of suppression / furnishing of false information, non-payment of **Application Fee** (if applicable). For queries candidates may visit the link and consult the Frequently Asked Questions (FAQ) section.

Write the system generated on-line application serial number on the **Application Fee receipt** for future reference.

- III. For Candidates those who worked with ECIL as Sr. Artisan/Jr. Artisan on fixed tenure based contract and claiming relaxations have to provide a copy of relieving letter & service certificate issued by ECIL along with list of documents pertaining to date of birth, educational qualifications, experience, Caste etc.
- IV. The candidate has to quote advertisement number, post name and On-line system generated application number for all future correspondence.

- Caps, hats and dark glasses are not acceptable, religious headwear is allowed but it must not cover your face.
- Size of the file should be less than 100kb.

**ii. Signature Image:**

- The applicant has to sign on white paper with Black Ink Pen.
- The signature must be signed only by the applicant and not by any other person.
- If the applicant's signature on the OMR Sheet at the time of the examination does not match the signature on the Attendance Sheet / Hall Ticket, the applicant will be disqualified.
- The signature of the candidates should be in running hand and not in block or capital or disjointed letters. If the signatures are not matching either at the time of written examination or document verification before personal interview, the candidature of the candidate will be cancelled.
