The Scope of Engagement :

01. The visiting consultant will be engaged as Radiologist / Sonologist.
02. He / she is required to conduct all ultrasound scans and report X-rays.
03. He / she has to visit BEML Medical Centre, Bangalore Complex twice in a week, viz., on Tuesday and Friday or on call in case of emergency.
04. Visiting hours will be for four hours per day from 12 noon to 04.00 PM.

General Terms & Conditions of Engagement :

01. He / she should possess the qualification MBBS, DMRD/MD, Radiology / DNB.
02. The visiting consultant should have minimum of 5 years of post-qualification experience in their respective specialized areas.
03. The age of the Visiting Consultants should not be more than 60 years.
