A. JOB REQUIREMENT

The Consultant is required to perform the following jobs:-

1. Strategic planning for devising Unit-wise/ Port wise/ State wise.
2. Agency-wise Rail/Road dispatch plan
3. Monitoring of dispatch as per movement order given by Department of Fertilizers as well as Rail, Road coefficient.
4. Monitoring dispatches and distribution of fertilizers as per '**least cost module**'
5. Control of D&C Cells at all the units and dispatches from all the ports.
6. Liaison with Department of Fertilizers, Railways etc.
7. Processing of sale terms of all the products for all the sales.
8. Coordination/monitoring of S&D jobs of all the Zones.

B. ESSENTIAL QUALIFICATION: Full time M.Sc. Agriculture or MBA from a recognized University/ Institution.

C. G. REMUNERATION

Consolidated fixed remuneration of Rs. 1,00,000/- per month. The payment shall be made on pro-rata basis depending upon the number of days of attendance. Income Tax shall be deducted as per rules. However, in case, traveling outside Delhi / NCR in the context of the work / assignment is required, the TA/DA shall be equivalent to the entitlement of Sr. Manager (E-5) level in the Company as per Company's TA Rules. In addition, Rs. 500 per month shall be allowed on the basis of self-certification for tele-communication expenses. No other allowance will be payable. No conveyance shall be provided for coming to or going from office.
