The student should have interest in doing experimental research which includes working with different electronic devices and measuring instruments. As this project includes device fabrication, the candidates will be required to work with some of the clean room facilities.

Documents Required	Applicant should have an online version of all original certificates including mark sheets (matriculation onwards), experience certificate(s), monthly emoluments/salary drawn, and all other relevant documents (including one set of the self-attested certificate(s)/document(s) and updated Curriculum Vitae.

Qualification obtained has to be from a recognized University/Institute. Eligibility in terms of age, qualification and experience of a candidate shall be considered as on the date of Selection Process.
3	The number of vacancies indicated in the notification is tentative. IIT Dharwad reserves the right to increase or decrease the number of advertised posts at the time of selection. Further, IIT Dharwad reserves the right to NOT fill any of the posts advertised.
4	No TA/DA will be paid for attending the Selection Process.
5	In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after issue of the appointment letter, the Institute reserves the right to <i>modify</i> , <i>withdraw</i> or <i>cancel</i> any communication made to the Applicants.
