**Mode of Selection:**

- *Shortlisting of Candidates Based on the Short - listing Criteria* Candidates in the ratio of 1:10 shall be short-listed based on the criteria in Para.
- *Waiting List:* 1:5 will be maintained for future.

**In final merit list,** if there are two or more candidates in the same category having equal marks:

- a) Candidate who has secured higher marks in examination shall be placed higher in merit.
- b) In case where the marks are same the candidate who will be having higher qualification will be placed higher in the final merit list and the qualifications are also same, the candidate who had secured higher marks in the highest qualification shall be placed higher in the final merit list.

6. Applicant should ensure that he/she possesses essential educational qualification and experience in the relevant area as required for the post, for which he/she is applying, on the last date of Submitting online application.
