CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **02 (Two)** positions of **PROJECT ASSOCIATE LEVEL - I** initially for a period upto **March 2022** (Extendable up to March 2023) on temporary contractual basis in the project entitled **“SEED-ENDOPHYTE INTERACTION: Strategies to reduce mycotoxins (fungal secondary metabolites) in cereal grains during storage conditions through seed-endophyte interactions” (MLP-0287)** funded by CSIR tenable at the Department of **Food Protectants & Infestation Control**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M.Sc in Microbiology / Biotechnology / Biochemistry / Botany (Min. 55% of marks).

Job Requirements: Working experience in Endophyte biology / Mycotoxin biosynthesis / Fungal biology / Plant pathology is required.

Emoluments: Rs. 25,000/- (Rupees Twenty Five Thousand Only) plus HRA per month.

1. Candidates should not have exceeded **35** years of age as on **20-01-2022** i.e. the last date of receiving the applications.
2. The engagement of **PROJECT ASSOCIATE LEVEL – I** is exclusively for the above-mentioned research work.
3. The engagement will be contractual and on purely temporary basis for a maximum period of one year or co-terminus with the project, whichever is earlier.

5. Performance of the Project Staff will be reviewed every six months. In case the performance is not satisfactory, the fellowship could be terminated with one month's notice or one month's stipend in lieu thereof.
