III. PERIOD OF CONTRACT APPOINTMENT:

- 1. The tenure of contract appointment will be 3 years.
- 2. The contract of appointment may be terminated by either side by giving 3 months' notice or by paying the contractual remuneration of three months in lieu of notice period, if the circumstances so warrant.

IV. CONDITIONS:

- 1. Candidates working in BMRCL who desires to apply for the above posts, Degree holder should have minimum 3 years' experience and Diploma holders minimum 5 years' experience in BMRCL in the post one level below the respective post for which they are applying.
- 2. Candidates who have been shortlisted will only be called for interview.
- 3. The experience is post qualification and the minimum required. Mere possession of minimum experience does not confer any right to be called for interview / selection.
- 4. Any canvassing by or on behalf of the candidates or to bring political or other outside influence with regard to selection/appointment shall be a disqualification.
- 5. Selection will be through interview by a Committee constituted by the Competent Authority.
