Applications are invited in the prescribed form for filling up the following posts of

QUALIFICATIONS:

I. Subject Matter Specialist:

S.No.	Name of the Post	Qualification
1.	Subject Matter Specialist (Agronomy)	Master's degree in Agronomy or equivalent qualification from a recognized University.
2.	Subject Matter Specialist (Horticulture)	Master's degree in Horticulture or equivalent qualification from a recognized University.
3.	Subject Matter Specialist (Home Science)	Master's degree in Home Science or equivalent qualification from a recognized University.

II. Farm Manager:

- i) A Bachelor's degree in Agriculture / Horticulture from a recognized Agricultural University with good academic record with a minimum OGPA of 6.50/10.00 or CGPA of 2.25/4.00 or its equivalent or 55% of marks (where grade points are not in vogue).
- ii) A relaxation of minimum OGPA from 6.50/10.00 to 6.00/10.00 and CGPA of 2.25/4.00 to 2.00/4.00 is provided for SC/ST category (55% to 50% of marks where grade points are not in vogue).

Note: Kannada speaking, reading and writing is essential for all KVK posts in UAS, Dharwad.

AGE LIMIT:

The minimum and maximum age limits for candidates to make application to these posts shall be as prescribed in the Karnataka Civil Services (General Recruitment) Rules, 1977, and as amended from time to time.

Minimum	18 years
Maximum	
For General Merit candidates	35 years
For Cat.2A, 2B, 3A, 3B candidates	38 years
For SC, ST & Cat.I candidates	40 years

The relaxation in maximum age limit for in-service, ex-serviceman, differently abled & widow candidates shall be provided as per KCS(General Recruitment) Rules.

MODE OF RECRUITMENT

- 1) The mode of recruitment to the post of Farm Manager shall be in accordance with the University Notification No.R/BOR-37(33):2017-18 dated 19.07.2017, which is briefed as under:
 - a. The mode of selection for the post of Farm Manager shall be through a Competitive Examination consisting two papers carrying 200 marks each along with negative marking to the extent of 0.25 marks for each wrong answer. The first paper shall be a General Paper and the second shall be a Specific Paper determined keeping in view the nature of job.
 - b. Eligible applicants shall only be called for examination. The said examination shall be conducted using OMR sheets.
 - c. Based on the marks scored in the competitive examination, candidates shall be called for verification of originals in the ratio of 1:5 for each post based on the roster.
 - d. Only those applicants who score at least 60% of the marks in examination shall be eligible for selection. In case of SC/ST applicants, a relaxation of 5 marks is provided.
 - e. The selection of candidates shall be solely based on the marks scored by the candidates in the competitive examination. In case, two or more candidates secure equal marks in the competitive examination, the order of merit of such candidates shall be fixed on the basis of their age, the person older in age being placed higher in the order of merit.
- 2) The qualification, Score Card and Selection Procedure for selection of candidates for the post of Subject Matter Specialist are in accordance with the University Notification No.R/BoM-59(44)/2021-22 dated 02.02.2022.

INSTRUCTIONS TO THE APPLICANTS:

1. The entire notification along with all the details & application pro-forma prescribed for the notified posts is accessible from the official website (<http://www.uasd.edu>) of the University of Agricultural Sciences, Dharwad.
2. The candidates applying for these posts have to enclose application processing fee in the form of Indian Postal Order / Demand Draft / Bankers Cheque for **Rs.600/- (For SC/ST applicants Rs.300/- only)** payable to the **"Comptroller, UAS, Dharwad"** drawn within the period from **22.03.2022 to 21.04.2022** while submitting the filled in application pro-forma.
3. The persons claiming reservation under Hyderabad-Karnataka Region have to enclose requisite certificate issued by the competent authorities in support of their claim. In case of employees of UAS, Dharwad, only those who have exercised their option for the State Level Regional Cadre are eligible to apply for the posts earmarked for candidates belonging to Hyderabad-Karnataka Region.
4. Persons other than those belonging to Hyderabad-Karnataka Region need not apply for the posts under the said quota.
5. If candidates belonging to Hyderabad-Karnataka Region are not available for the post reserved for the said category, the vacancy will be carried forward for future notifications as a backlog.
6. Separate applications with separate fee & supporting documents should be submitted for each of the posts applied. Applications for two different posts should not be tagged together.
7. The roster prescribed for the posts notified herewith is in accordance with the following Karnataka State Government Orders (a) No. SiAaSul:21:SaHiMa:90, Bangalore, dt. 16.11.1995 (b) No.SiAaSul:08:SaHiMa:95, Bangalore, dt. 20.06.1995 (c) No.SiAaSul:42:SeNeNi:2001, Bangalore, dt. 23.07.2001 (d) No.SiAaSul:97:SeNeNi:2002, Bangalore, dt. 22.11.2002 (e) No.DPAR 50 SRR 2000, dt. 03.09.2005 (f) SiAaSul:107:SeNeNi:2005, dt. 05.09.2005 and as amended from time to time. Further, reservation for persons belonging to Hyderabad-Karnataka Region is provided as per GOK notification dated 07.01.2014.
8. As per the G.O. dated 03.10.2015, in case of non-availability of suitable candidates for the posts earmarked for Cat.I, 2A, 2B, 3A & 3B, the respective posts shall not be de-reserved and will be carried forward as backlog.
9. Candidates claiming reservation under Rural Category quota should enclose the certificate of study in rural areas (for 10 full academic years from 1st to 10th standards) issued by the competent authorities.
10. Candidates claiming reservation under Kannada Medium Quota should enclose the certificate of study in Kannada medium (for 10 full academic years from 1st to 10th standards) issued by the competent authorities.
11. Further, in case of non-availability of candidates belonging to special categories under horizontal reservation such as Rural, Woman, Kannada Medium & Ex-servicemen categories, the posts earmarked for the said categories shall be filled-up by other candidates belonging to the respective reservations as per the provisions of the Government Order No.SiAaSul:08:SaHiMa:95, Bangalore, dt. 20.06.1995.
12. The applicants belonging to General Category & Cat.2A/2B/3A/3B, who claim reservation under Rural candidate quota have to produce a certificate issued by the competent authority confirming that they do not come under the purview of creamy layer in the prescribed form, while submitting the application form, as per the Government Circular No.SaKal:26:BiCiA:2002, dt. 06.03.2002.

13. Differently abled, Ex-servicemen or children of defense personnel killed or disabled in action are exempted from payment of application fee provided they enclose appropriate certificate along with the filled-in applications.
14. Knowledge of reading and writing Kannada is desirable for the posts. The persons with working knowledge of Kannada will be preferred.
15. The candidates who have studied under Trimester System and other than 10 point grading system are requested to produce the equivalent percentage certificates obtained from the respective University.
16. Working hours of the University: 9.00 am to 5.00 pm (Saturday: 9.00 am to 1.00 pm)
17. Applications must be accompanied by attested copies of documents in support of their claim. A list of enclosures page numbered serially must be appended to the application.
18. No applicant for any post shall be eligible for appointment if he/she is, at the time of his/her application, is in permanent employment in any other Department of Government or any other State Government or Central Government or Quasi Government or any other University and has made the application without the consent of the Head of the Department or of the Government or Head of the University, as the case may be, under whom he/she is employed. Accordingly, candidates already in service (Government/Quasi Government or private) should submit their applications through their Controlling Officers as indicated supra. Candidates anticipating delay in sending their applications through proper channel, may submit an advance copy of the application within the prescribed last date along with the processing fee. However, candidates who submit advance copies of application have to produce NOC from their employer at the time of interview, failing which, their candidature for the post applied will be rejected.
19. All communications in respect of applications for recruitment against the posts advertised by the University should be addressed to the Registrar, University of Agricultural Sciences, Krishinagar, Dharwad – 580 005(Karnataka).
20. The vacancies and roster now notified are provisional and are subject to variations. The University reserves the right to fill-in any or all the vacancies.
21. The processing fee will not be reimbursed in any case.
22. For all recruitments to the posts in the University, other things being equal, the University (UAS, Dharwad) employees shall be given preference.
23. **Filled-in applications together with copies of testimonials should be sent in an envelope, super scribing on it, "APPLICATION FOR THE POST OF _____" to THE REGISTRAR, UNIVERSITY OF AGRICULTURAL SCIENCES, DHARWAD – 580 005(KARNATAKA), on or before 5.00 PM on 21.04.2022 from the candidates staying in India and abroad.** The candidates staying abroad may download the application format from the official website (www.uasd.edu) and submit the application forms along with the relevant documents and the prescribed fee in foreign currency.
24. Applications received after the last date and incomplete applications will be rejected. If any candidate submits more than one application for the same post, the latest application received before the last date will be considered as valid for the purpose of recruitment.
25. Furnishing any false information in the application form shall hold the candidate liable to action deemed fit.

26. No recommendations should be forwarded to the University. Canvassing in any form will lead to disqualification of candidature.
27. No person shall be appointed to any post in the University unless the appointing authority is satisfied that the selected candidate is of good character and is in all respects suitable for appointment to University service.
28. The candidates shall attend the competitive examination, interview and for the process of verification of documents at their own cost.
29. The selected candidates have to produce a Police Verification Certificate issued by the Competent Authority. If the Police Verification Certificate reveals that the candidate is involved in any criminal case or is involved in an act which attracts moral turpitude, will result in cancellation of his/her selection. However, production of Police Verification Certificate is not mandatory for candidates who are already in regular service of Government/Statutory Bodies/Universities/ICAR institutes.
30. The appointed candidates are governed by the Act & Statutes, Regulations etc. of UAS, Dharwad.
