- c) In addition to the above no other allowances like D.A, N.P.A, HRA etc. would be payable.
- d) No Private Practice is allowed during the tenure of service in ESIC.

4. TERMS OF CONTRACT:

- a) Selected candidates shall be appointed purely on contractual basis for the maximum period of one year as mentioned against vacancy above or till the joining of regular faculty whichever is earlier.
- b) The contractual engagement may be terminated / discontinued on either side after giving one-month prior notice to this effect without assigning any reason.
- c) Other terms and condition will be applicable as issued by competent authority from time to time.
- d) This being One-year contract, absence for period beyond 15 days will be treated as abandonment of duty and the contract will be terminated without any reason and security deposit will be forfeited.

7. SELECTION PROCEDURE:

- Selection will be made on basis of interview of candidates which will be conducted by the duly constituted selection board.
- b) 50% of the total marks would be considered as the criteria for eligibility for selection.
- c) Selected candidates will have to report this office for Verification of original certificates immediately after receiving Provisional offer of Appointment.
- d) The final selection will be based on performance in the personal interview.
- e) Offer of appointment will be provisional subject to verification of original certificates at the time of joining.
- f) Waiting list will be prepared and will be valid for a period of 1 month from the date of release of result subject to the approval of the Competent Authority.

8. GENERAL CONDITIONS:

- a. Mere submission of application does not confer any right to the candidate to be interviewed.
- b. The applications found to be incomplete will be summarily rejected.
- c. Wrong declarations/submission of false information or any other action contrary to law shall lead to cancellation of the candidature at any stage.
- d. On the day of Walk-in-Interview, the candidates should produce No Objection Certificate (NOC) from present employer.
- e. Opportunity of interview given to candidates will be on provisional basis.
- f. The candidates who have applied for higher post may opt for lower post during the interview in the same department.
- g. The interview shall be conducted at the Office of the Dean, ESIC Medical College, Kalaburagi. However, ESIC reserves the right to change the venue and dates, if needed.
- h. Canvassing in any form will lead to disqualification.

- j. Rules of reservation will be implemented as per Government of India's instructions.
- k. No TA/DA will be admissible for interview or joining.

- m. Teaching faculty is eligible for only One (01) day leave per month after completion of month.

9. CRITERIA OF INCOME & ASSETS (For Economically Weaker Section or EWS)

Persons who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below Rs.8.00 Lakh (Rupees Eight Lakh only) are to be identified as EWSs for the benefit

of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application.

Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income: -

- 5 acres of agricultural land and above;
- II. Residential flat of 1000 sq. ft. and above;
- III. Residential plot of 100 sq. yards and above in notified municipalities;
- IV. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.

The term "Family" for this purpose will include the person who seeks benefit or reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years.

10. INCOME AND ASSET CERTIFICATE ISSUING AUTHORITY AND VERIFICATION OF CERTIFICATE:

The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authorities in prescribed format as given in **Annexure-I** shall only be accepted as proof of candidates claim as belonging to EWS:

- ii. Chief Presidency Magistrate/Additional Chief Presidency Magistrate/Presidency Magistrate.
- iii. Revenue Officer not below the rank of Tehsildar and
- iv. Sub-Divisional Officer or the area the candidate and/or his family normally resides.
