CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (ONE)** position of **PROJECT ASSOCIATE LEVEL - I** initially for a period of **March 2023** or till the project is over on a temporary contractual basis in the project entitled **“Non- digestible carbohydrates as functional mimics of human milk oligosaccharides” (MLP-272)** funded by CSIR tenable at the Department of **Molecular Nutrition**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M.Sc. in Microbiology.

Job Requirements: Bacterial cell, culture and biochemical assays.

Emoluments: Rs. 25,000/- (Rupees Twenty Five Thousand only) plus 16% HRA per month.
