Terms and Conditions

- The eligible and interested persons may send their application alongwith copy of testimonials duly self attested in the requisite proforma given at Annexure-I and Annexure-II only through e-mail at recruitment@alimco.in on or before **31.05.2022**. The applications received after **31.05.2022** shall not be entertained. "NAME OF THE POST APPLIED FOR" must be mentioned in subject. Only Indian Nationals need to apply.
- Physically fit and mentally agile candidates below the age of 35 years for the post of IT Consultant, 40 years for the post of Finance Consultant and 65 years for the post of Advisor (Vigilance) having adequate experience will be considered.
- No TA/DA will be paid for attending the interview. However, after joining corporation contractual engagement shall be allowed TA/DA for their official tour inside the country as per corporation rule.
- Tenure Initially for a period of Two year for IT Consultant, one year for Finance Consultant and 1 year for Advisor (Vigilance) which may be extended the sole discretion of the Corporation. Engaged person shall have no claim for appointment on regular basis by virtue of being engaged on contractual basis. The incumbents are liable to be transferred/ posted anywhere in India at the discretion of ALIMCO.
- The selected candidates should be able to join at the earliest. Candidates should ensure that they full fill the eligibility criteria prescribed for the post they have applied in case it is found at any stage of selection process or even after appointment that the candidate has furnished false or incorrect information or suppressed any relevant information/ material facts or does not full fill the criteria, his / her candidature / services are liable for rejection/ termination without notice.

6. During the validity of the Contract of engagement, while on duty, engaged person shall (i) observe the punctuality & discipline (ii) attend Office on all working days, and, if necessary on holidays. If required, he/she will have to work even beyond normal office hours.
7. The engaged person will be entitled to draw a consolidated monthly remuneration as mentioned above in the respective post during the validity of this contract.
8. The engaged person will be entitled to casual leave one day for each completed calendar month.
9. The engaged person shall be paid prorated salary beyond consolidated monthly remuneration if he /she works beyond normal working hours, on holidays, closed Saturday & Sunday.
10. If Fixed Terms Contract (FTC) works beyond normal working hours i.e. 8 hours then such no. of hours shall be recorded in daily Attendance Register. The extra duty hours shall be justified & verified by the controlling officer and duly approved by the HOD/Location Incharge for process payment.
11. Illustration- If any FTC works on Holiday, closed Saturday and Sunday and beyond normal working hours i.e. 8 hours on any working days then remuneration calculation of his extra duty should be as below, say-

1 st day extra hours	02
2 nd day extra hours	03
3 rd day extra hours	03
Total extra hours worked in that week/month	08 hours

- **Extra Remuneration for 08 hours (1 day extra) formula=**
Consolidated monthly remuneration (Rs. 75000/-)
No. of working day (say 26 day)
- if his consolidated monthly remuneration is Rs.75000/- then for 1 day (8 hours) extra remuneration shall be Rs.2885/- per day, if No. of working day in particular month is 26.
- likewise for extra duty on Holiday, closed Saturday & Sunday FTC shall get Rs. 2885 (75000/26=2885) for each extra day duty accomplished.

12. This Contract of engagement is terminable by the Corporation at any point of time without prior notice if the performance of the engaged person is not found satisfactory.
13. The engaged person also reserves his/her right of terminating this Contract of engagement by giving the Corporation one month's prior notice in writing or payment of consolidated remuneration for one month in lieu thereof.
14. If the engaged person does not attend office on any working day, the remuneration would be worked out by applying the following formula:-
 - (i) IT Consultant

$$\frac{\text{Number of working days on which office has been attended} \times 35000/-}{\text{Number of working days in the month}}$$
 - (ii) Finance Consultant

$$\frac{\text{Number of working days on which office has been attended} \times 40000/-}{\text{Number of working days in the month}}$$
 - (iii) Advisor (Vigilance)

$$\frac{\text{Number of working days on which office has been attended} \times 75000/-}{\text{Number of working days in the month}}$$
15. The engaged person will have no right to claim any additional benefit/compensation/absorption/regularization of services in the Corporation during or after the period of engagement under any provision.
16. The engagement will be for a period of Two year for IT Consultant, one year for Finance Consultant and 1 year for Advisor (Vigilance). However, depending on the requirement of the Corporation and the performance of the person engaged, the period of engagement can be extended. The services of the contract employee may be terminated at any time even before the completion of the said period.
