#### I. Essential Experience

The Candidates should have minimum 18 years of post-qualification experience, out of which minimum 03 years must be in diverting utilities of 400kV / 220kV / 132kV / 110kV / 66kV/ 33kV/ 11kV transmission lines.

#### II. Desirable Experience

Experience in State utility is preferable.

#### 4. JOB DESCRIPTION:

The incumbent for the post shall be responsible for all Utility Diversion related works pertaining to the Delhi Metro Rail Corporation Ltd.

#### 5. SCREENING PROCESS:

The selection methodology for candidates applying on <u>Post Retirement Contractual Engagement basis</u> shall comprise of **Personal Interview.** 

Candidates shall be called for Interview in the ratio of 1:5, subject to availability of eligible candidates. The selection process would judge different facets of knowledge, skills, comprehension, aptitude and physical fitness. No reimbursement on account of travel shall be made to the candidates appearing for the screening.

### 6. SCHEDULE OF SELECTION:

i. Last date of receipt of duly filled in application (along with relevant documents) through Speed post, OR, e-mail shall be 18/07/2022. Incomplete applications, or, applications received after the due date, shall be summarily rejected. DMRC shall not be responsible for loss / delay in post.

- ii. The list of shortlisted candidates shall be uploaded on DMRC website in the Fifth week of July 2022 (tentatively) and interview shall be held in the First week of August, 2022 through online mode (tentatively) (complete details shall be displayed on DMRC website).
- iii. No separate communication, by post, shall be sent to the candidates individually. Candidates are advised to go through the instructions/schedule for the interview displayed on DMRC website and appear for the interview, accordingly, along with the original copies of the testimonials.
- iv. The final result shall be declared by second week of August, 2022. (Tentatively).
