- **Reservation of Person with Benchmark Disability(PWD) will be as per prevailing guidelines of Government of India. - b) The consolidated remuneration under “SRESTA” Scheme for retired Army Doctors (Teaching – Broad Specialty) who meet the eligibility criteria for Faculty posts is as Under:

- c) In addition to the above **no other allowances** like D.A, N.P.A, HRA etc. would be payable.  
d) No Private Practice is allowed during the tenure of service in ESIC.  
e) In case of engagement of retired employees/pensioners, they may be allowed to draw full consolidated remuneration without any deduction as it is not a case of re-employment in terms of Central Civil Services (Fixation of Pay of Re-Employed Pensioner) Orders 1986 and retired employees/pensioners can continue to draw pension and dearness relief on pension during their period of contractual engagement.  
f) Retirees from Central/State Govt./PSU from the equivalent posts are eligible to Apply. Persons working in recognized / approved private Medical Institutions fulfilling eligibility criteria for the post may also apply.

#### 6. TERMS OF CONTRACT:

- a) Selected candidates shall be appointed purely on contractual basis for the maximum period of one year (extendable up to Three years depending on satisfactory performance) as mentioned against vacancy above or till the joining of regular faculty whichever is earlier.  
b) The contractual engagement may be terminated / discontinued on either side after giving one-month prior notice to this effect without assigning any reason.  
c) Other terms and condition will be applicable as issued by competent authority from time to time.  
d) This being One-year contract, absence for period beyond 15 days will be treated as abandonment of duty and the contract will be terminated without any reason and security deposit will be forfeited.

**9. SELECTION PROCEDURE:**

- a) Selection will be made on basis of interview of candidates which will be conducted by the duly constituted selection board.
- b) **50% of the total marks would be considered as the criteria for eligibility for selection.**
- c) Selected candidates will have to report this office for Verification of original certificates immediately after receiving Provisional offer of Appointment.
- d) **The final selection will be based on performance in the personal interview.**
- e) **Offer of appointment will be provisional subject to verification of original certificates at the time of joining.**
- f) **Waiting list will be prepared and will be valid for a period of 1 month from the date of release of result subject to the approval of the Competent Authority.**

**10. GENERAL CONDITIONS:**

- e. Equivalent Teaching Experience Certificate issued by DGAFMS for retired Army Medical Teachers at the time of Interview.

- f. Opportunity of interview given to candidates will be on provisional basis.
- g. The candidates who have applied for higher post may opt for lower post during the interview in the same department.
- h. The interview shall be conducted at the Office of the Dean, ESIC Medical College, Kalaburagi. However, ESIC reserves the right to change the venue and dates, if needed.

**11. CRITERIA OF INCOME & ASSETS (For Economically Weaker Section or EWS)**

Persons who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below Rs.8.00 Lakh (Rupees Eight Lakh only) are to be identified as EWSs for the benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application.

Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income: -

- I. 5 acres of agricultural land and above;
- II. Residential flat of 1000 sq. ft. and above;
- III. Residential plot of 100 sq. yards and above in notified municipalities;
- IV. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.

The term "Family" for this purpose will include the person who seeks benefit or reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years.

**12. INCOME AND ASSET CERTIFICATE ISSUING AUTHORITY AND VERIFICATION OF CERTIFICATE:**

The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authorities in prescribed format as given in **Annexure- I** shall only be accepted as proof of candidates claim as belonging to EWS:

- iv. Sub-Divisional Officer or the area the candidate and/or his family normally resides.
