1. Indian Institute of Science (IISc), Bangalore invites applications for the position of Psychiatric Social Worker (PSW) in the Wellness Centre at the Institute. The details of the position are as follows:

2. Job Profile/Responsibilities

- A psychiatric social worker helps people who struggle with mental health problems and cope with them.
- PSW provides counseling services to clients to help them to cope with psychological problems.
- PSW meet with other members of the mental health team (psychiatrists, nurse practitioners, etc.) to discuss Client care.
- Psychiatric social workers should also offer individual and group therapy sessions to patients.
- PSW should conduct regular awareness training for supporting staff and the Institute community to make them aware of mental health and mental hygiene.
- Maintain case records and prepare reports of each patient.
- Wellness coordinators are required to be available on campus on all working days and on Saturdays for the campus Institute community. They are also available to attend to an emergency at any time.
- All other works assigned from time to time.
- Works related to the SAP implementation, custom queries, reports, or other technology resources.

3. Duration

Engagement is purely temporary on a contract basis, initially for a period of **one year** and renewable annually up to a maximum duration of **five years**, based on the satisfactory performance and discretion of authorities of the Institute. Contract tenure will commence from the date of joining.

4. **Selection Procedure:** An interview will be held at the Indian Institute of Science Campus, Bangalore for shortlisted candidates.

(d)	The shortlisted candidates will be informed through e-mail about the date & time of the selection process. Candidates are also advised to provide the correct information in their application.
(e)	If required, the electronic mode of interview (Zoom Call/ Microsoft Team) will be conducted and the same will be intimated to the candidates in advance. It is advised that the candidates should be prepared to give interviews in all the medium, if so required.
(f)	In case the interview is held in person, no TA/DA shall be paid for attending the interview.

(d)	Candidate, if selected, must join immediately and no later than four weeks after the offer of appointment is received.
(e)	Qualifications other than one prescribed in this advertisement will not be accepted.
(f)	Engagement on a contract basis would be subject to medical fitness.
(g)	Selection for the post does not entitle any claim whatsoever of permanency or regularization against any regular post or any vacancy arising in the future in this or any other cadre/post on the basis of this service. The Institute can fix the consolidated salary lower/ higher in the given range depending on qualification and experience.
