SC/ST and Female candidates are exempted from paying the fee.

- Candidates whose applications are screened as per norms will be called for interview
- No TA/ DA will be admissible to attend the interview
- Relaxation to SC/ST/OBC/PH will be as per rules

- The last date for receipt of application will be 30 days from the date of publication of
  advertisement in Employment News. If the last date happens to be a Sunday or closed
  holiday, the next working day will be taken as crucial last date. The crucial date for
  determining the age limit shall be the closing date for receipt of application from
  candidates.
- 2. Maximum Age Limit for the Post of Sr. Scientist & Head: Should not exceed more than 47 years as on closing date of application.
- 3. Maximum Age limit for the Post of Subject Matter Specialist (Animal Science): Should not exceed more than 35 years as on closing date of application.
- 4. Maximum Age limit for the Post of Driver (LMV): Should not exceed more than 30 years as on closing date of application.
- 5. Maximum Age limit for the Post of Supporting Staff Should not exceed more than 25 years as on closing date of application.
- 6. Age relaxation to SC/ST/OBC/PH Candidates is as per Government of India rules.
- 7. Duly Signed application in the prescribed format along with self attested copy of certificates including proof for date of birth and self attested photo affixed in the application should be addressed to "The Secretary, Board of Management, KLE Society, College Road, Belagavi-590 001 and preferably sent by registered post only. The envelope should be superscribed as "Application for the post of Sr. Scientist/Head KVK / Subject Matter Specialist (Animal Science)/T-6 / Driver-T-I/ Skilled Support Staff.
- 8. If the candidate applies for more than one post, separate applications are required for each post.
- 9. KVK, its management or funding agency will not be responsible for any postal delay.
- 10. Employed applicants should send the applications through their employer with **No Objection** Certificate in original.
- 11. Incomplete application(s) in any form and the application(s) received after due date will not be considered.
- 12. DA/HRA/Transport allowances are only payable. No provision for other allowances.
- 13. The candidate should be himself / herself confirm his / her eligibility for the post applied for, before submission of application. No correspondence, whatever, in this regard shall be made /entertained.
- 14. KLE Society, Board of Management, College Road, Belagavi reserves the right to fill the post or cancel the advertisement.
- 15. A DD from Nationalized Bank for a sum of Rs. 1,000/-(Non refundable) as processing fees drawn in favour of **Programme Co-ordinator**, **KLE KVK**, **Mattikopp** enclosed with application. SC/ST and female candidates are not required to submit the processing fee.

Incomplete applications; applications without supporting documents *viz.*, proof for date of birth, proof for claiming age relaxation, proof of minimum/essential qualifications and/or DD and applications received after due date will be summarily rejected without any notice and no correspondence in this regard will be entertained.
- 17. KLE KVK Belagavi 2 is functioning under the Acts and Statutes of KLE Society and not under ICAR as a Grant in Aid Scheme. Hence, the posts are Non-Governmental under KLE Society and no other allowances other than indicated above shall be payable.
