# NOTIFICATION FOR CALLING APPLICATIONS FOR APPOINTMENT OF MEMBER (LEGAL) OF THE KARNATAKA ELECTRICITY REGULATORY COMMISSION

- 1. The Karnataka Electricity Regulatory Commission (KERC) is an independent Regulatory Body consisting of a Chairman and two Members. One post of Member (Legal), KERC will be vacant from 31.12.2023. The State Govt. has constituted the Selection Committee as required under Section 85(1) of Electricity Act, 2003 for selection and recommending panel of names to the Govt. for appointment of Member (Legal), KERC.
- **2.** Applications are invited from suitable persons for selection and appointment of Member (Legal) of the Karnataka Electricity Regulatory Commission.
- 3. Qualification and Experience required for applying to the post of Member (Legal), KERC:
  - a) The applicant applying for the post of Member (Legal) of the KERC shall be a person of ability, integrity and standing who has adequate knowledge of Law.
  - b) The applicant should be one who is or has been holding a judicial office or is a person possessing professional qualifications with substantial experience in the practice of law, who has the requisite qualifications to have been appointed as a Judge of the High Court or a District Court.

- c) The applicant must be a citizen of India and should have the working knowledge of Kannada.
- 4. The person appointed for the post of Member (Legal) shall hold office for a period of 5 years from the date of his/her appointment as Member (Legal) or until he/she attains the age of 65 years, whichever is earlier.
  - The person appointed as Member (Legal) is not eligible for reappointment for the same post in the Commission at any time after the expiry of his/her term of appointment.
- **5.** A person having any financial or other interest which is likely to affect prejudicially his/her functioning as Member (Legal) of the Commission, is not eligible.
- **6. REMUNERATION:** As per KERC (Chairman and Other Member's Remuneration / Allowance and Conditions of Service), Rules 2000 and as amended from time to time.
- 7. LAST DATE FOR SUBMISSION OF APPLICATION: The applicants should file their application along with the copies of the testimonials and declarations by Registered Post/ Courier / in person / through online (along with scanned copies of the documents) to the e-mail: <a href="mailto:prs.energy@gmail.com">prs.energy@gmail.com</a> addressed to the Additional Chief Secretary to Government, Energy Department, Room No. 236, 2nd floor, Vikasa Soudha, Dr. Ambedkar Veedhi, Bangalore 560 001 on or before 11.12.2023 by 5.30 PM.
- **8.** Application should be in the prescribed Form-1 (Annexed) duly singed by the applicant
- **9.** The applicant shall furnish a declaration to the effect that he/she does not have any business or any financial interest in any office, employment or consultancy agreement or arrangement in his/her own name or in the names of any relative, in any firm, association of persons or body corporate on such aspects/issues.

- 10. The Applicant shall furnish a declaration to the effect that he/she does not have any financial or other interest which is likely to affect prejudicially his functioning as such Member (Legal), KERC.
- 11. The applicant shall furnish a declaration that he/she shall not hold any other office during the tenure in KERC, if selected and appointed as Member (Legal) in KERC.
- **12.** The Applicant shall furnish a letter of willingness to resign or take voluntary retirement from the present post and to join KERC if selected and appointed as Member (Legal) in KERC.
- **13.** The decision of the Selection Committee is final with regard to selection of candidates for appointment for the post of Member (Legal) in KERC.
