# ELIGIBILITY CRITERIA FOR THE POST OF FULL TIME SUPER SPECIALIST:

1. The appointment will be for a minimum period of ONE year (Extendable to another one year) or till regular incumbent joins or attaining 70 years of age, whichever is earlier. The said contract would be extendable yearly subject to satisfactory performance, requirements etc. The Appointment shall not confer any right or preference for regular appointment. Further, such Appointments also subject to Medical fitness.

2.Candidates must be registered with Karnataka Medical Council or MCI before joining the post.

3.No TA/DA will be admissible for attending the interview or joining for duty.

4.ESI Corporation may increase or decrease or cancel filling up of any post without assigning any reasons at the discretion of the Appointing Authority.

5. The application should be submitted in the prescribed format only at the time of interview. The applications found to be incompletewill be summarily rejected.

6.The Dean has the discretion to increase/decrease the number of vacancies depending upon actual requirement/Cancel this recruitment/ withdraw the Offer of Appointment issued after the Walk ininterview.

7.The candidates are advised to bring their application (prescribed format attached) along with 2 photographs and 1 set of self attested copies and original marks cards of

- a) SSLC Certificate for proof of age
- b) MBBS and MD/MS/DNB Degree from MCI recognized Medical College/Institution.
- c) DM/MCH in respective Super Speciality from MCI recognized Medical College/DNB in concerned Super Speciality or equivalent.
- d) Should have registered with MCI or State Medical Council.
- e) Five years experience in the concerned speciality after obtaining the first post Graduate degree.

8. The Full time Super Specialist is entitled for the leave @ 04 days for each month of work on a prorata basis in a calendar year. In the event, the Super specialist prefers not to avail the leave; the same may be encashed to a maximum limit of 30 days.

Qualifications with regard to experience are relaxable at the discretion of the Appointing Authority on recommendation of the Selection Committee in case of candidates otherwise well qualified.

### Emoluments and Terms & Conditions:-

### Full time Super Specialists:

1.Super Specialist (Entry Level)- Rs.2,00,000/- (Consolidated remuneration) per month plus other allowances as admissible if any.

# 2. Consultant (Senior Level) – Rs.2,40,000/- (Consolidated remuneration) per month plus other allowances as admissible if any.

Consultant with at least five years post super speciality qualification experience will be considered for engagement as Consultant (Senior Level).

9.All candidates are directed to report for interview at New Academic Block, Dean's Office, ESIC Medical College, Rajajinagar, Bangalore -10

10.Candidates are requested to get themselves registered within the time as mentioned above, failing which they will not be allowed to appear for interview.

11.The candidate appointed as Full Time Super Specialist shall tender one month prior notice in case he/she wishes to resign from the job or to deposit one month salary in lieu of notice period.

12. Upon selection the candidates have to open an SB Account in State Bank of India before reporting for duty.

13. Hostel Accommodation/Quarters will not be provided.

14. The doctors at any time found guilty of any gross misconduct or negligence of his/her duties shall be terminated without any notice or payment in lieu of notice period.

15. The Full Time Super Specialist has to wear his/her own white coat with name badge during the duty hours.

16.The MS/Dean will be the Controlling Authority for Full Time Super Specialist.

17. The Selected Full time Super Specialist must have a professional indemnity policy which should cover the period of contractual engagement. The policy is meant to cover professional liability falling on them as a result of error and omissions committed by them while rendering professional

services. The minimum sum assured per annum should be Rs.30 Lakh for Anaesthesiologists, Cardiac Surgeon, Neuro Surgeons, Plastic Surgeons etc.(2) Rs.20 Lakhs for General Surgeons, Gynecologists, Obstetrician etc.(3) For Physicians Dentists, Radiologists, Pathologists etc. it should be at least of Rs.10 Lakh. A copy of the Insurance & Premium and receipt must be submitted within 7 days from the date of engagement.

**18.** The selected candidates will have no claim for regularization of services in the Hospital/Medical Institution.

19. The appointing authority reserves the right to terminate the appointee anytime even before the tenure without assigning any reason by giving one month notice. Similarly, the engaged person will have to give one month prior notice before resigning or will have to pay an amount equivalent to one month's remuneration in lieu of the notice period.

20. The Super Specialist shall be available on call 24x7.

21. The Super Specialist shall be responsible for all cases undergoing treatment under his supervision in that specialty discipline.

22. He/ She will be required to mark attendance manually as well as AEBAS (Aadhar Enabled Based Bio Metric Attendance System)
