Maintain and optimize networks and servers, both on-premise and on cloud. Monitoring and Maintenance: Monitor system performance and troubleshoot issues promptly. Implement preventive maintenance strategies to ensure the stability and reliability of IT systems. Manage installations, upgrades and configurations of hardware and software. Incident Response: Respond to and resolve system-related incidents, working closely with the IT support team. Document incident resolutions and contribute to the development of incident response procedures. Infrastructure Planning: Maintaining a strong understanding of the organization's business needs and working closely with other departments to ensure that IT is aligned with those needs.
